- ☐ Copy of Tennessee Sales Tax Registration
- ☐ Copy of Tennessee Business License
- ☐ Current exemptions certificate from the Internal Revenue Service issued under Section 501(c)(3) of the IRS Code of 1954 as amended or proof of membership in charitable or religious organization represented.
- ☐ Name, permanent address, phone number, social security number, driver's license number, and state of issue for any person other than the applicant who will be transacting business at this location for this business or organization. Attach a separate sheet to this application.
